- Fees will increase at a standard rate per year and fee schedules will be made available to School District before the close of the previous calendar year. Fees are subject to change with 30 days notice.
- Arrival/Departure dates are specific for this location
 - Full package rates cover the expense of arrival on the required/recommended dates as follows:
 - **Arrival** on or after <u>August 26, 2025</u> (10 months) or <u>August 26, 2025 OR January 30, 2026</u> (5 months). Arrival dates prior to these dates will incur additional charges.
 - **Departure** prior to <u>June 30, 2026</u> (10 months) or <u>January 30, 2026 OR June 30, 2026</u> (5 months). Departures after this date must be approved by head office and additional charges will be incurred.
- A deposit of \$_2250.00 is required at time of application to begin processing the custodian paperwork. Final payments are due 60 days prior to arrival. MLI Homestay provides one host family profile based on the student details provided in the application
